- First and Second round of counselling will be as per PTU reservation Policy with 85% reservation to Punjab Domicile and 15% to outside Punjab and domicile rank of candidates will be base of allotting seats .
- In the Third counselling, ,NIIFT will convert all the unfilled reserved seats to General Category and seats will be then allotted to available seats as per common merit list which will be displayed on 16th August 2020.
- Candidates are instructed to appear through zoom link detailed on call letters as per scheduled time in all the counselling session, name of the candidate will be called online and present candidate will be allotted seat as per merit out of available seat. In case,candidate is not present at time of calling of his/her name incounselling, the seat will be allotted to the candidate next in merit . candidate cannot claim his/her merit then.
- Once candidate isallotted with seat in any counselling, he/sheisrequired to make payment of Rs.58000/- through SBI collect link available on NIIFT Website through online mode within two days , failing which , allotted seat will be again open for allotment to other candidate in merit .

- If candidate is allotted seat under Punjab Domicile Reservation or any other reservation, he/she must submit the proof/ certificate of it on or before 16th August 2020, failing which his/her seat will be reallocated in third counselling as per common merit list to the available seat and centre. Candidate claim for reservation will be nullified then and seat allocated to candidate in first or second counselling will be cancelled.
- Candidates are instructed to appear in all the round of counselling to keep themselves updated for seats available and allotted.
- Seats allotted in first and second counselling can be swapped to other course and other centre in third counselling for seats available at the merit of candidate called.
